

If an employees of the council after getting financial up-gradation under Modified Assured Carrier Promotion Scheme gets regular promotion in the same/upgraded pay scale, no further fixation of pay at the time of regular promotion shall be granted.

The financial up-gradation under MACP/MFCS Scheme has been considered on the basis of recommendations received from the respective Institute.

In the event of any overpayment as a result of financial up-gradation under MACP/MFCS Scheme, if pointed out by the Audit or as a result of subsequent Government instructions/orders, the same shall be recoverable from the officials concerned.
