**MEETING FOR DPR PREPARATION FOR YAMUNA REJUVENATION AT
PRAYAGRAJ BY FRCER, PRAYAGRAJ**

A meeting cum workshop organized for briefing the formats of information sought from Uttar Pradesh Forest Department for the preparation of Detailed Project Report for Rejuvenation of Yamuna river through Forestry Interventions on 05th October 2019 at DFO Office, Prayagraj Forest Division, Pt. Madan Mohan Malviya Park, Prayagraj, Uttar Pradesh. In workshop forest officials and field level staff from Prayagraj, Kaushambi and Fatepur Forest Divisions actively participated.

The meeting cum workshop was inaugurated and chaired by Mr. K. P. Dubey PCCF (Project), UP Forest Department, Lucknow. Mr. Y.P. Shukla DFO, Prayagraj Forest Division and Mr. P. K. Sinha, DFO Kaushambi Forest Division, Dr. Sanjay Singh, Head, FRCER, Prayagraj and Dr. Kumud Dubey, Scientist and Nodal Officer for Uttar Pradesh for Yamuna DPR co-chaired the session.

Workshop was inaugurated by Mr. K. P. Dubey PCCF (Project). At inception, Dr. Sanjay Singh, Head, FRCER, Prayagraj welcomed the participants and presented a brief overview about various aspects of the formats devised by FRI Dehradun for collection of requisite information for different forestry interventions for preparation of DPR for Yamuna rejuvenation.

Dr. Kumud Dubey, Scientist and Nodal Officer (UP) made a detailed presentation of the project and appraised about the formats viz. Natural Landscapes, Agricultural Landscape, Urban Landscape, Conservation and Extension Strategies.

Dubey PCCF (Project), UP Forest Department, Lucknow instructed to Forest Officials from Prayagraj, Kaushambi and Fatepur Forest Divisions about regarding modus operandi for collection of the information. He also requested from the Scientists of FRCER, Prayagraj to provide technical support for collecting the information and filling the formats for different Forestry interventions.

The technical session was followed by interactive session with active participation of forest officials and field staff. The queries and doubts raised by the forest officials regarding the format filling clarified by the scientists from FRCER, Prayagraj.
