### > SCOPE OF WORK :-

The modified Technical specifications have been revised as follows:

1. Under the Scope of Work point no.7 may be read as follows:

• Landuse to be prepared from Satellite Data (23.5 m or higher resolution ) using visual interpretation supervised classification on 1:50,000 scale (Built-up Land, Agricultural Land, Forest, Waste Lands, Water Bodies and Areas which are important or sensitive for ecological reasons like Wetlands, watercourses or other water bodies, biospheres, mountains, forests, Protected Areas, Notified Eco-sensitive areas, mangroves etc.) Interpretation has to be carried out at 1:35,000 scale and outputs to be prepared at 1:50,000 scale.

- 2. In addition to the existing scope of work as per revised tender document the following point may be added:
  - Output format State wise and Sub-basin wise.

3. All other terms and conditions other than those mentioned in this corrigendum remain the same.
