4. Quoted price will be evaluated and contract will be awarded to the responsive bidder offering the lowest evaluated rate.
5. Quotation should be accompanied by adequate technical documentation and catalogue(s) and other printed material or pertinent information for each item quoted, including names and addresses of supplier providing after sales service facilities.
6. The deadline for receipt of quotation through GeM is **07 August 2024 by 05:00 PM**.
7. The prices should be quoted in Indian Rupees and should be inclusive of all taxes (GST). No price increase will be allowed after the submission of Quotations.
8. Validity of the Offer: Quotation shall be valid for a period of 90 days from the date for receipt of quotation(s) indicated in Paragraph 6 above.
9. Evaluation of Quotations: The Procurement Committee of RECAP4NDC-PMU, ICFRE will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed and conform to the terms and conditions and specifications of the Bid document.
10. Award of contract: The contract for supply of camera will be awarded to the Firm whose quotation has been determined to be substantially responsive and who has offered the lowest price as per the specifications in the Bid document.
11. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the procurement process and reject all quotations at any time prior to the award of contract.
12. The Firm whose quotation is accepted will be notified for the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the contract.
13. All prices should be quoted F.O.R. destination inclusive of all taxes and contingent costs including, customs packing and forwarding, transportation, handling and insurance etc.
14. Standards: The Camera supplied under the contract shall conform to the standard prescribed/ specification mentioned there, against the goods in the financial bid.
15. ICFRE shall not be responsible for fluctuation of the market rate of the ordered above mentioned items. The firm shall be required to supply the above mentioned Camera at agreed rate only. The contract may be terminated at any time due to non-performance of any of the terms and conditions of the contract to the satisfaction of the Corporation.
16. The RFQ will be evaluated by the procurement committee of RECAP4NDC Project, ICFRE and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit an undertaking in this regard.
17. ICFRE shall have the sole and unfettered discretion to decrease/ increase the number of above-mentioned Camera to be purchased from the firm within the validity of the contract.
18. Payment shall be made after successful delivery and installation of the goods.

1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted.
