3. Qualifying and Eligibility Criteria for submitting the bid:

- a) **Firm must have at least five (5) years of experience in printing of books/ reports/ documents. Documentary evidence in the form of Work Orders/ Contracts/ Work Completion Certificates of each year of last 5 years of same must be submitted by the firm.**
 - b) **Firm must have minimum average annual turnover of Rs. 11,00,000/- for last 3 years. Documentary evidence of same duly verified by CA must be submitted by the Firm.**
 - c) **Copies of registration/ taxation documents (Company Registration Certificate/ PAN Card, GST Certificate, Aadhar Card, etc.) must be submitted by the Firm.**
 - d) **Firm must to submit a self-declaration certificate of not having blacklisted in any government department/organization during the last 3 years.**
 - e) **Firm must to submit samples of books/ reports/ documents of similar or equivalent specifications printed by the Firm.**
 - f) **An office of the firm must be located in the state of Uttarakhand. Documentary evidence of same must be submitted by the firm.**
4. Eligible firms are invited to submit their bid for digital printing of above-mentioned reports for Project Management Unit, RECAP4NDC project as per specifications mentioned in Para 2.
 5. Quoted price will be evaluated and contract will be awarded to the responsive bidder offering the lowest evaluated rate.
 6. Bid should be accompanied by adequate technical documentation and catalogue(s) and other printed material or pertinent information for each item quoted.
 7. The deadline for receipt of bid through GeM is **15 September 2025 by 05:00 PM.**
 8. The prices should be quoted in Indian Rupees and should be inclusive of all taxes (GST). No price increase will be allowed after the submission of Bid.
 9. Validity of the Offer: Bid shall be valid for a period of 90 days from the date for receipt of Bid(s) indicated in Paragraph 7 above.
 10. Evaluation of Bid: The Procurement Committee of RECAP4NDC-PMU, ICFRE will evaluate and compare the Bid determined to be substantially responsive i.e. which are properly signed and conform to the terms and conditions and specifications of the Bid document.
 11. Award of contract: The contract for printing of reports will be awarded to the Firm whose Bid has been determined to be substantially responsive and who has offered the lowest price as per the specifications in the Bid document.
 12. Notwithstanding the above, the ICFRE reserves the right to accept or reject any Bid and to cancel the procurement process and reject all Bids at any time prior to the award of contract.
 13. The Firm whose bid is accepted will be notified for the award of contract by the Purchaser prior to expiration of the bid validity period. The terms of the accepted offer shall be incorporated in the contract.
 14. All prices should be quoted F.O.R. destination inclusive of all taxes and contingent costs including, customs packing and forwarding, transportation, handling and insurance etc.
 15. Standards: The printing of reports supplied under the contract shall conform to the standard prescribed/ specifications mentioned there, against the works in the financial bid.
 16. ICFRE shall not be responsible for fluctuation of the market rate of the ordered above mentioned works. The firm shall be required to supply the above-mentioned reports at agreed rate only. The contract may be terminated at any time due to non-performance of any of the terms and conditions of the contract.
 17. The Bid will be evaluated by the procurement committee of RECAP4NDC Project, ICFRE and the findings of the committee will be final and binding. The same cannot be challenged at any forum thereafter. Intending bidder will have to submit an undertaking in this regard.
 18. ICFRE shall have the sole and unfettered discretion to decrease/ increase the number of above-mentioned reports to be printed by the firm within the validity of the contract.
 19. Payment shall be made after successful completion of work.
 20. The Principal Investigator, RECAP4NDC Project, ICFRE reserves the right to cancel the contract on ground of unsatisfactory or delayed supply and failure to fulfill terms and conditions of the bid document and contract.

21. Materials of REACP4NDC Project books/reports/documents is highly confidential and shall not be disclosed to third party in any case. Any violation in this regard will attract legal action.
22. Final drafts in colour (Colour Dummy) shall be made available to the Principal Investigator, RECAP4NDC Project, ICFRE and only after approval of the dummy, final print shall be taken.

1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and

technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. 4. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.

5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
